**Demand for Payment**

There being no constitutional authority that gives pretended USDC Tyler Division Civil Action No. 6:14-cv-595 or pretended USDC Lufkin Division Civil Action No. 9:14-cv-138 the capacity to take jurisdiction and enter a judgment, order, or decree in favor of the United States arising from a civil or criminal proceeding regard a debt, in Tyler County, Texas: There is no constitutional authority for either of said pretended civil actions—and the above-named actors, with intent to establish, maintain, and participate in a combination, in dereliction / criminal negligence / defiance of the express and implied provisions of the Constitution relating to jurisdiction, in respect of the legislative powers therein conferred upon Congress, and violation of oath of office, if any, and treason to the Constitution, conspired to commit theft of Complainant Affiant’s real property in Tyler County, Texas, under pretext of a judicial proceeding and color of law, office, and authority.

Wherefore, in accordance with (1) that certain Affidavit of Information, Form AOI-011416, sworn to and signed by John Parks Trowbridge, Jr. and witnessed by three competent witnesses January 14, 2016—made fully part hereof and included herein by reference as though set forth in full—and filed with 65 senior officers in military authority, the Chief Justice of the Supreme Court of the United States, and the Chief Judge of the United States Court of Appeals for the Fifth Circuit, and (2) the enclosed Verified Accounting of Offenses and Debt, Form VAOD-011416, made fully part hereof and included herein by reference as though set forth in full, **Demand hereby is made** for payment in full of the following respective amounts of indebtedness of the following debtors, current as of this date, within twenty (20) days of receipt hereof:
